Normal Lab Results	If left blank, all labs with the provider's name attached to the account will go to Home Screen. To limit, select any combination of the following: attending, secondary, primary or consulting	Lab	This alert displays all normal lab results
Secure Patient Message from Patient Portal	N/A	Secure Patient Message	This alert displays messages sent from patient via Thrive's patient portal.
Scanned Images	If left blank, all labs with the provider's name attached to the account will go to Home Screen. To limit, select any combination of the following: attending, secondary, primary or	Scanned Image	Notifications of available scanned images from Electronic File Management. Notification is sent to the Home Screen when the item is scanned into Thrive.
