

# **Read Only Access to Charts**

This document outlines the necessary security required to give a user read only access to patient charts. Keep in mind that this security only applies to patient accounts accessed from the Charts option via the Application Drawer. It **does not** provide read only access to patient accounts accessed from the System Menu option.

The access outlined in the document will provide the user with limited demographic and visit information available when searching patient charts. Users will only be able to Search (for patients) by Profile and View Visits for the patient. It does not allow access to the options available on the Navigation Panel within the patient's chart.

## **Role Setup**

1. Create a new Read Only Role.

- Code: Enter a unique code up to 8 characters in length.
- **Description**: Enter a description for the Read Only role. (ex. Read Only)
- Navigation Role: Select HIM.

Complete the following fields:

- Login: Enter the user's login. This may be 3-5 characters in length. It must begin with a lowercase letter and any other letters within the login must also be lower case.
- First Name/Middle Name/Last Name: Enter the user's name.
- **Thrive Version**: Select either Thrive or Thrive UX. If Thrive UX is selected, the login will only be able to login using Thrive UX. If Thrive is selected, the user will have the option of choosing Thrive or Thrive UX when signing into the system.
- **Embedded Version**: Select either Embedded Version 1 or Embedded Version 2. The embedded version will determine how users will view embedded screens within Thrive UX.
- Web Client External Access: When selected, the user may access the EHR via the Web Client when connecting both in and out of the facility's network. Once selected, the 'Require MFA' option will become available to set for users. When 'Web Client External Access' is not selected, the user may only access the EHR via the Web client when in the facility's network; the user will not be able to access the EHR when out of network.
- **Require MFA**: When selected, a One-Time Password (OTP) is required when accessing the EHR via the Web Client when connecting out of network. When this option is not selected, an OTP is not required when accessing the EHR via the Web Client.

Select **Save**. Choose a password option then select **Update**.



4. Add Facility access to the login.

Double-click the boxes under the following fields and complete the information:

- User Identity: Find the employee number created in Step 1 and associate it with the login.
- Roles: Select the Read Only role. (This must be created first using the steps listed above.)

**NOTE**: The Departments and CSNumbers(s) sections should remain blank.

## Additional Access

Additional security may be given to allow users access to the Navigation Panel options on the patient's chart. Keep in mind that some fields accessed on these screens cannot be locked down to view only, therefore the user may be able to make changes.

It is recommended that this security be added at the user level and NOT on the Read Only role. If it is preferred to add this security to a role, then it is recommended that a separate limited access role be created.

#### Create a Screen Rule Allowing Access to Specific Navigation Panel Options

# Select Web Client > Application Drawer > System Administration > Logins > Select User > Navigation Panel > Screens > New

- Step 1: Select Screen.
- Step 2: Select Allow.
- Step 3: Select the bold text **Screen**, then select **Add**. Choose the desired screens using the table below that lists the different Navigation Panel Options. Then select **Insert**.
- Select Save.
- Enter a Rule Title.
- Select OK.
- Select Back Arrow.

The following table lists the Navigation Panel options available for roles associated with the HIM Navigation Role. Each option will include the name of the Navigation Panel option, the launcher name needed for the screen rule, a description of the information that can be found on that screen as well as any items that are accessible and able to be changed.

#### Diagnosis

The Diagnosis screen provides access to the diagnoses coded on the account. Screen access cannot be given to the Diagnosis screen at this time. However, diagnoses entered on this screen may be viewed on the Coding Summary report that is accessible on the Patient Summary screen (see above).

Description:	Displays all orders placed on a patient's account in chronological order.
Unrestricted Items:	PDF option

Description:	Allows access to the Patient Demographics Selection screen. Additional security is needed for each demographics option.

Description:	Displays census and clinical information that has already been entered for the patient.
Unrestricted Items:	The following fields are unrestricted and may be edited and saved: Care Level, Condition, Violent Patient, Restraints, MRSA, VRE, Isolation, Pregnant, Breast Feeding, Diabetic, Fluid Restriction, Sodium Restriction, Terminally III/Long Term Care, Risk for Falls, Food Dislikes, LTCH Calculation Indicator.

Unrestricted Items:	The following fields are unrestricted and may be edited and saved: Patient Name, Birth Sex, Religion, Email, Ethnicity, Preferred Language, Advanced Directive, DNR, Notify in Emergency, Relation, Phone, Caregiver, Decline to Specify.
Demographics - Facesheet	
Launcher Name:	No additional security needed. This screen can be accessed with access to the Patient Demographics Selection screen.
Description:	Displays the patient's facesheet.
Unrestricted Items:	Once accessed facesheets can be downloaded and printed.
<b>Demographics - Arr</b>	nbands and labels
Launcher Name:	demographics_labels
Description:	Allows armbands and labels to be printed for the patient.



Unrestricted Items:	Armbands and labels can be printed using this option.
Demographics - Care Team Event Notifications	
Launcher Name:	care_team_event_notification
Description:	Displays a listing of added physicians the patient has requested to be notified
	when they are admitted, discharged or transferred from the facility.
Unrestricted Items:	Care team information displayed can be edited and saved. Care team
	information may also be deleted.

Medical Necessity	
Launcher Name:	coverage_existing_list
Description:	Displays any existing ABNs. To view the ABN details, access to the
Unrestricted Items:	None

Visit History	
Launcher Name:	visit_history
Description:	Allows all visits attached to the patient's to be reviewed and accessed. When a different account is accessed from Visit History, only the options given thru the user's role and/or login will be accessible.
Unrestricted Items:	PDF option

Allergies	
Launcher Name:	patAllergies
Description:	Displays the allergies listed on the patients account and profile.
Unrestricted Items:	Can use the Remove, NKA, NKDA, NKEA, and NKFA options.

Patient Immunization History	
Launcher Name:	pat_immuniz_list
Description:	Displays an electronic record of a patient's immunizations.
Unrestricted Items:	Can use the Remove option.

Charges	
Launcher Name:	charges, charge_item_lookup
Description:	Displays the charge entry screen.
Unrestricted Items:	Charges may be posted and credited. Pending charges may be removed.

Electronic Forms	
Launcher Name:	patient_eforms
Description:	Displays eforms entered on the account. Only the Title, Last Update, Created, and Status may be viewed for the eform. To show the eform access to the launch_eform_view screen must be added.
Unrestricted Items:	If access is given to launch_eform_view the user may be able to add new eforms and lock existing eforms.
